

## **GRATIS NAME & LIKENESS RELEASE**

For good and valuable consideration, the receipt and sufficiency of which is hereby confirmed, I hereby grant to Live Nation Productions, LLC, and its respective agents ("Company"), and all others working for or with it or on it's behalf, and their respective parents, subsidiaries, affiliates, related entities, employees, directors, officers, contractors, licensees, successors, and assigns (collectively, the "Permitted Parties"), the right and permission (but not the obligation) to photograph, record, reproduce or otherwise use my image, name, voice, performance, biographical information and/or likeness (collectively, "My Persona") as it appears in the video and/or photographs of the video (the "Video") and in the Materials described below, in the Territory and Media, and for the Term, described below for any lawful purpose whatsoever an unlimited number of times. I further agree that the Video (including My Persona) may be edited or altered as the Permitted Parties so choose, combined with any material the Permitted Parties so choose, to create the Materials (as defined below), which Materials may be used during the applicable Term, and in the Territory and Media (as such terms are defined below) and in any format, and for purposes of advertising and trade in connection with the Permitted Parties and their products and services.

- Materials: The full-length documentary feature film tentatively entitled "UNTITLED DAN REYNOLDS DOCUMENTARY," and in any extra materials (i.e., including but not limited to behind-the-scenes), derivative materials created therefrom and in any and all trailers and/or promotion and/or marketing materials created in connection therewith.
- Territory: The universe
- Media: All media (including but not limited to theatrical, free television, pay television, pay-per-view, video on demand, home video (including but not limited to DVD and wireless), internet streaming, television streaming), and in any other media now known or hereinafter devised.

Term: In perpetuity

I hereby irrevocably waive any and all so-called moral rights I may have in the Video and Materials. I hereby forever release, discharge and hold harmless the Permitted Parties from and against any and all claims (including, without limitation, claims based upon invasion of privacy, defamation, or right of publicity) related to or arising out of the use of My Persona, the Video or the Materials or in connection with the exercise of any of the rights granted herein.

I represent and warrant that I have the right to enter into this Release and have no conflicting commitments or obligations that would interfere with the rights herein granted. I also agree that if that the use of My Persona falls within the jurisdiction of any union or guild, I agree to accept the minimum scale payments provided for in the applicable union or guild agreement. In addition, this Release shall constitute my agreement that no additional compensation is necessary in connection with the Permitted Parties' right to exercise unlimited editing rights in connection with such use

of My Persona. And, at the request of any of the Permitted Parties, I agree to execute any applicable union or guild contract. The undersigned agrees that no sum shall be due for the execution of this Release and that neither Company nor any Permitted Party shall be obligated to pay the undersigned or any third party any sum whatsoever, regardless of the time or method of any future use of the Video and/or Materials or exercise of any of the rights granted herein.

I understand and agree that the content, nature and direction the Video, the Materials and any related advertising campaign is confidential and that the terms of this Release are confidential. I agree that I will not disclose in any manner (including, without limitation, via text messaging, blogging or communicating in any way via Snapchat, Twitter, Facebook, or any other social networking website, tool or device, etc.) any non- public information regarding the Video, Materials or the related advertising campaign and I will not disclose any terms of this waiver to any third party.

This agreement contains the entire understanding between Company and me with respect to the subject matter hereof, may not be altered or waived except by a writing signed by both parties, and shall be governed by the laws of the State of California, the United States of America, applicable to contracts executed and performed entirely therein. Any action to enforce this agreement shall be brought exclusively in the state or federal courts located or having jurisdiction in the County of Los Angeles, California and I hereto irrevocably submit to the jurisdiction of such courts and agree to waive any objection that such courts are an inconvenient forum for the resolution of such action. Company may freely transfer or assign this agreement in whole or in part. I agree that I shall not be entitled to seek injunctive or other equitable relief or to enjoin or restrain the distribution, exhibition, advertising, or any other exploitation of the Video or Materials for any reason.

Should any section or part of a section within this agreement be rendered void or unenforceable by any court of competent jurisdiction, the remaining provisions of this agreement shall nevertheless be binding upon the parties with the same effect as though the void or unenforceable part had been severed and deleted.
